**THIS AGREEMENT CONTAINS ARBITRATION AND CLASS ACTION WAIVER PROVISIONS THAT
WAIVE YOUR RIGHT TO A COURT HEARING OR JURY TRIAL OR TO
PARTICIPATE IN A CLASS ACTION. ARBITRATION IS MANDATORY AND IS THE EXCLUSIVE
REMEDY FOR ANY AND ALL DISPUTES.**

RIZZBATES TERMS AND CONDITIONS. These Terms and Conditions apply to the RIZZBATES purchase of the person whose name or RIZZBATES number appears on the other side of this letter and/or any purchaser or user of the RIZZBATES service ("Service") described herein ("YOU," "You," "you", or "your"). RIZZBATES ("RIZZBATES") is an optional service provided, administered, or owned and operated by SEMPRIS, LLC, and/or its subsidiaries and affiliates. SEMPRIS, 13033 Ridgedale Drive, Suite 202, Minnetonka MN 55305 (collectively, "SEMPRIS," "We," "Us" or "Our").

THE SERVICE. In exchange for payment by you of the current RIZZBATES fee, you may obtain RIZZBATES. The benefits of RIZZBATES consists of discounts and savings opportunities, including limitations on redemptions, as described on the other side of this letter and/or on the RIZZBATES website. SEMPRIS reserves the right to change the specific services included in the RIZZBATES website and reserves the right to modify these terms and conditions without notice. SEMPRIS reserves the right to limit discounts. SEMPRIS reserves the right to change the content of the RIZZBATES website at any time. We reserve the right to cancel your RIZZBATES purchase and access to the website and the Service at any time for any reason. No Service benefits carry over or may be used after cancellation by You or Us or more than twelve (12) months following your purchase date.

WHO MAY USE. You must be a U.S. resident at least 18 years of age or the age of majority in your state of residence to purchase the Service. RIZZBATES is unavailable to residents of WI, IA, MN, UT and VT, and residents of FL, HI and NV are prohibited from receiving RIZZBATES benefits related solely to travel. Only you may use RIZZBATES for your benefit. If We discover that your RIZZBATES website or Service access has been used by or for someone other than you, or been compromised in any way, we reserve the right to cancel your access to the RIZZBATES website and the Service it provides, including the denial of any pending redemptions or purchases. No corporate, company, or business RIZZBATES purchases are permitted. You agree to notify Us if you become aware of any unauthorized use of your RIZZBATES purchase or website or Service access or if your RIZZBATES number is lost. This website is not directed at children under the age of 13. SEMPRIS does not intend to gather any personal information from children under 13. Children under the age of 18 should get permission from a parent or guardian before sending any personal information to Us via e-mail or otherwise. However, if the parent or guardian of a child under 13 has provided Us with personally identifiable information, the parent or guardian of that child should call Us at 800-475-1942 if they want this information deleted from Our files.

RIZZBATES BILLING. Your access to the RIZZBATES website and Service will begin on the date your purchase is recorded in our systems and will continue for a period of twelve (12) months thereafter unless and until you or We cancel. The card you provided at time of purchase, or any other current payment mechanism We have on file for you, will be automatically charged the price on the other side of this letter in four separate equal installments, the first of which will occur at

the time of purchase, with the remaining three (3) installment payments billed within the twelve (12) month period during which you can access the website and use the Service. To cancel your RIZZBATES purchase and website access, write to P.O. Box 5265, Hopkins, MN 55343-2265, Attn: Customer Service, or call 800-475-1942, or go to www.programstop.com to cancel online. Also, see "Right to Cancel RIZZBATES" below.

PAYMENT METHOD. You may edit your payment method information by calling Customer Service at 800-475-1942. If any payment is not successfully settled due to expiration, insufficient funds, or otherwise, and you do not edit your payment method information or cancel your purchase of or from RIZZBATES (See "Right to Cancel RIZZBATES" below), you remain responsible for any uncollected amounts and authorize Us to bill any payment method We have on file, as it may be updated. This may result in a change to your payment billing dates or a different card being charged for any of your purchases. We may update your payment method with information provided by the applicable payment service provider, and you authorize Us to continue to charge the RIZZBATES installment payment amount or any purchase you make from RIZZBATES to the updated payment method. If we are unable to successfully settle a payment for an installment, your access to the RIZZBATES website and Service will terminate after your paid period expires. For certain payment methods, the issuer of your payment method may charge you a foreign transaction fee or other charges. Check with your payment method service provider for details.

NO AUTOMATIC RENEWAL OR CONTINUATION OF SERVICE AFTER TWELVE (12) MONTHS.

Twelve (12) months after your purchase date, your access to the RIZZBATES website and Service will terminate. We may provide you the ability to purchase an additional twelve (12) months of RIZZBATES website and Service access, prior to their expiration, within the RIZZBATES website, or you may contact Customer Service at 800-475-1942 to arrange for the purchase and payment.

RIGHT TO CANCEL RIZZBATES. You have the right to cancel your RIZZBATES purchase at any time. To cancel, write to P.O. If you cancel your RIZZBATES purchase, you will not be charged any additional fees. When you cancel, access to the website and Service will end after your paid period has expired and any future RIZZBATES installment payment charges that would have been due will be cancelled.

ARBITRATION AND DISPUTES. This Agreement and any issue or dispute arising out of or otherwise related to this Agreement or with your use of Our website, the Privacy Policy, or any

matter concerning SEMPRIS including use and purchase of RIZZBATES, collectively "Disputes," shall be governed exclusively by the laws of the State of Minnesota, excluding its conflict of law provisions. If a Dispute arises under this Agreement, we agree to first contact each other with a written description of the Dispute, all relevant documents and information, and the proposed resolution.

You agree to contact Us with Disputes by writing to Us at SEMPRIS, 13033 Ridgedale Drive, Suite 202, Minnetonka MN 55305. SEMPRIS will contact you by letter to your billing address you provided Us.

If any Dispute cannot be resolved informally, we each agree that any and all Disputes, other than those either party may choose to file in small claims court, shall be submitted to final and binding arbitration before a single arbitrator under the auspices of JAMS in a location convenient to you. Either party may commence the arbitration process by submitting a written demand for arbitration with JAMS and providing a copy to the other party. The arbitration will be conducted in accordance with the provisions of the JAMS Consumer Arbitration Minimum Standards in effect at the time of submission of the demand for arbitration (available at <https://www.jamsadr.com/consumer-minimum-standards/>), which are incorporated by reference herein. We will pay all of the filing costs, including arbitrator fees. Judgment on the award rendered by the arbitrator may be entered in any court of competent jurisdiction.

Notwithstanding the foregoing, the following shall not be subject to arbitration and may be adjudicated only in the state and federal courts of Minnesota: (i) any dispute, controversy, or claim relating to or contesting the validity of our proprietary rights, including without limitation, trademarks, service marks, copyrights, or trade secrets; or (ii) an action by a party for temporary, preliminary, or permanent injunctive relief, whether prohibitive or mandatory, or other provisional relief. **You expressly agree to refrain from bringing or joining any claims in any representative or class-wide capacity, including but not limited to bringing or joining any claims in any class action or any class-wide arbitration.**

YOU UNDERSTAND THAT YOU WOULD HAVE HAD A RIGHT TO LITIGATE THROUGH A COURT, TO HAVE A JUDGE OR JURY DECIDE YOUR CASE AND TO BE PARTY TO A CLASS OR REPRESENTATIVE ACTION. HOWEVER, YOU UNDERSTAND AND CHOOSE TO HAVE ANY CLAIMS DECIDED INDIVIDUALLY AND ONLY THROUGH ARBITRATION.
